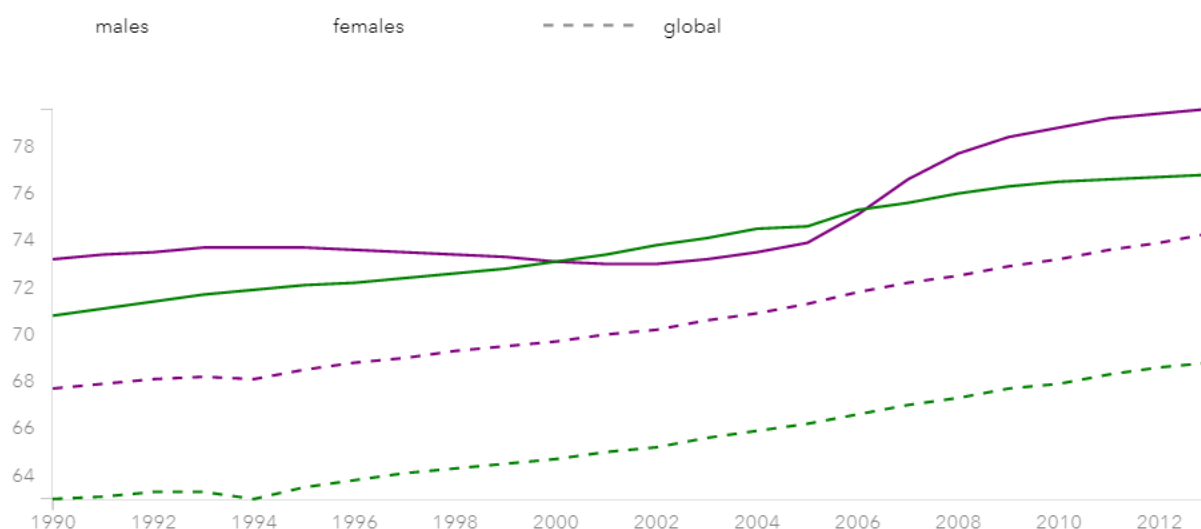


Jordan

This profile provides an overview of findings from the [Global Burden of Disease \(GBD\)](#). The information generated here is based on more than 50,000 different data sources which researchers have used to produce the most scientifically rigorous estimates possible. Estimates from the GBD study may differ from national statistics due to differences in data sources and methodology. These profiles are meant to be freely downloaded and distributed. - In 2013, life expectancy at birth in Jordan was 76.8 years for males and 79.6 years for females.
- Among the leading causes of disability-adjusted life years (DALYs) in 1990, measles showed the largest decrease, falling 69.6% by 2013.
- In terms of the number of years of life lost (YLLs) due to premature death in Jordan, congenital anomalies, ischemic heart disease, and neonatal preterm birth were the highest ranking causes in 2013.
- In terms of DALYs in Jordan, high body-mass index, high fasting plasma glucose, and dietary risks were the leading risk factors in 2013.
- The greatest reduction in all-cause mortality rate was experienced by females aged 28-364 days (56.5%).

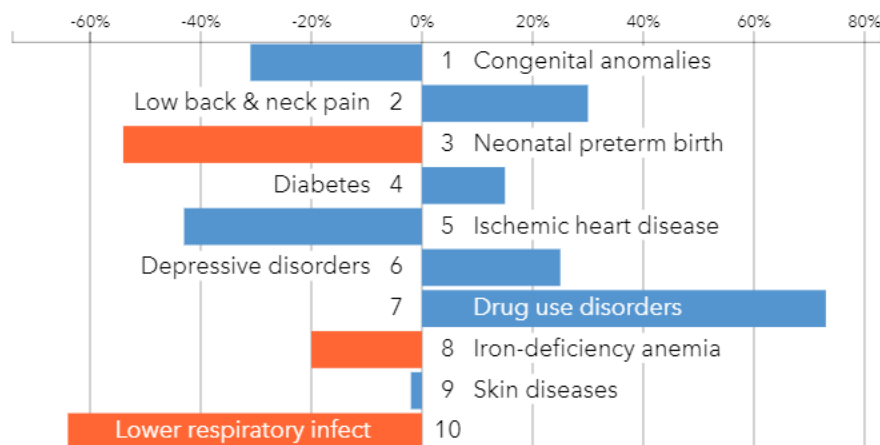
Life expectancy globally and in Jordan, 1990-2013

- Injuries



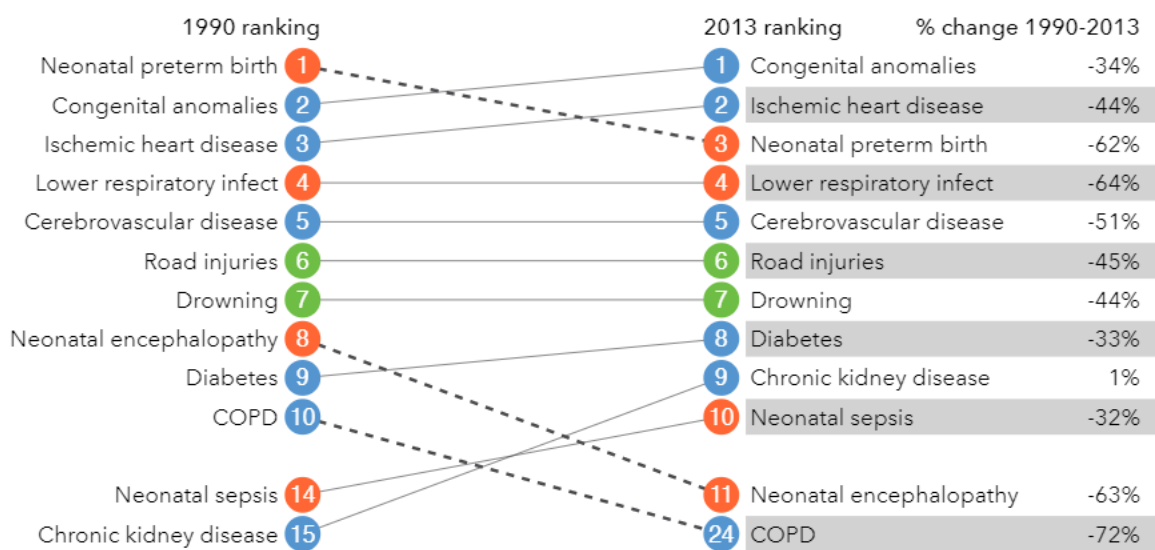
DALYs are the sum of years of healthy life lost to premature death and years lived with disability.

Pointed arrows indicate causes that have increased or decreased by a greater amount than shown on the x-axis.

Leading causes of YLLs to premature death, 1990 and 2013, and percent change, 1990-2013

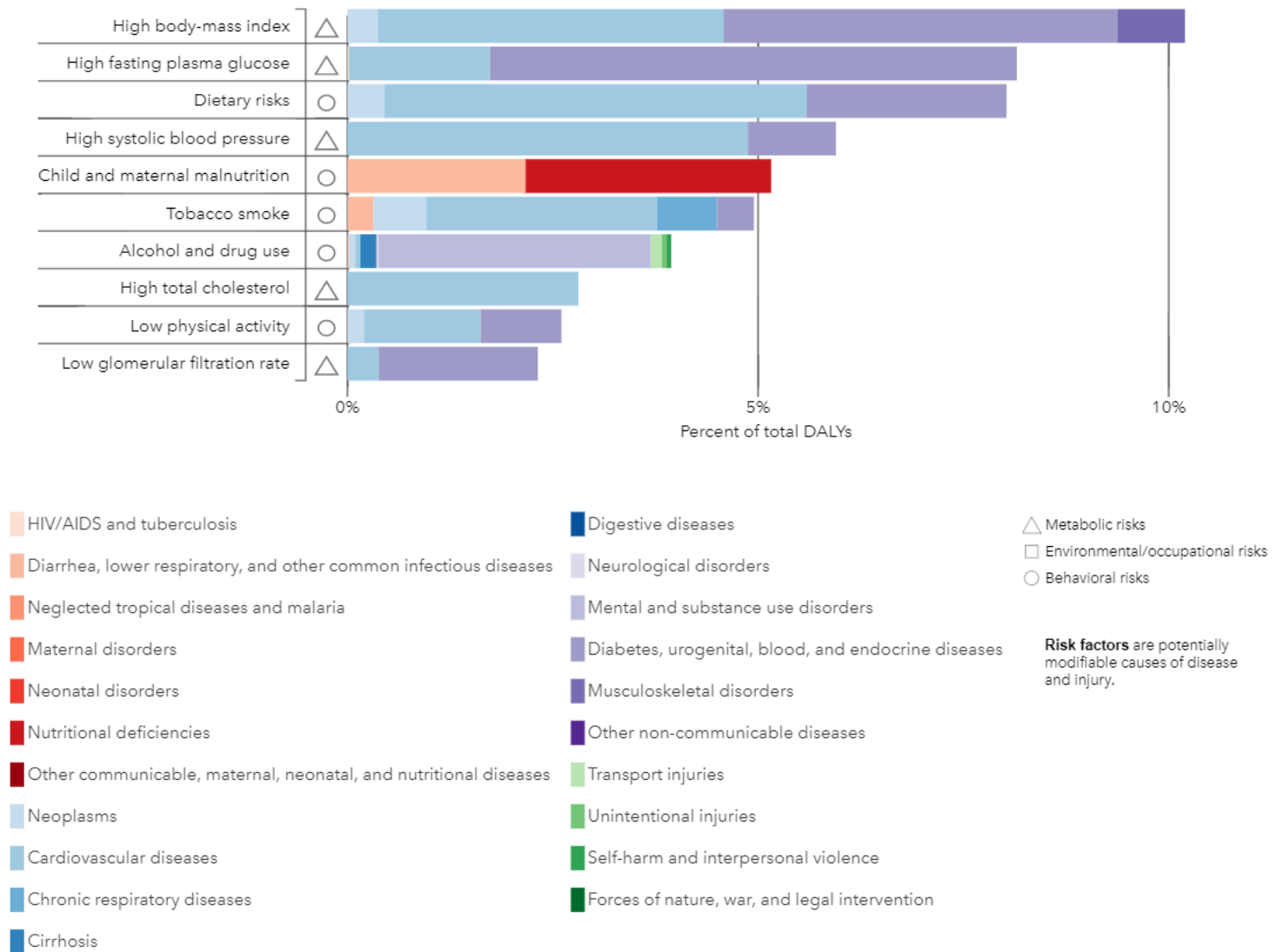

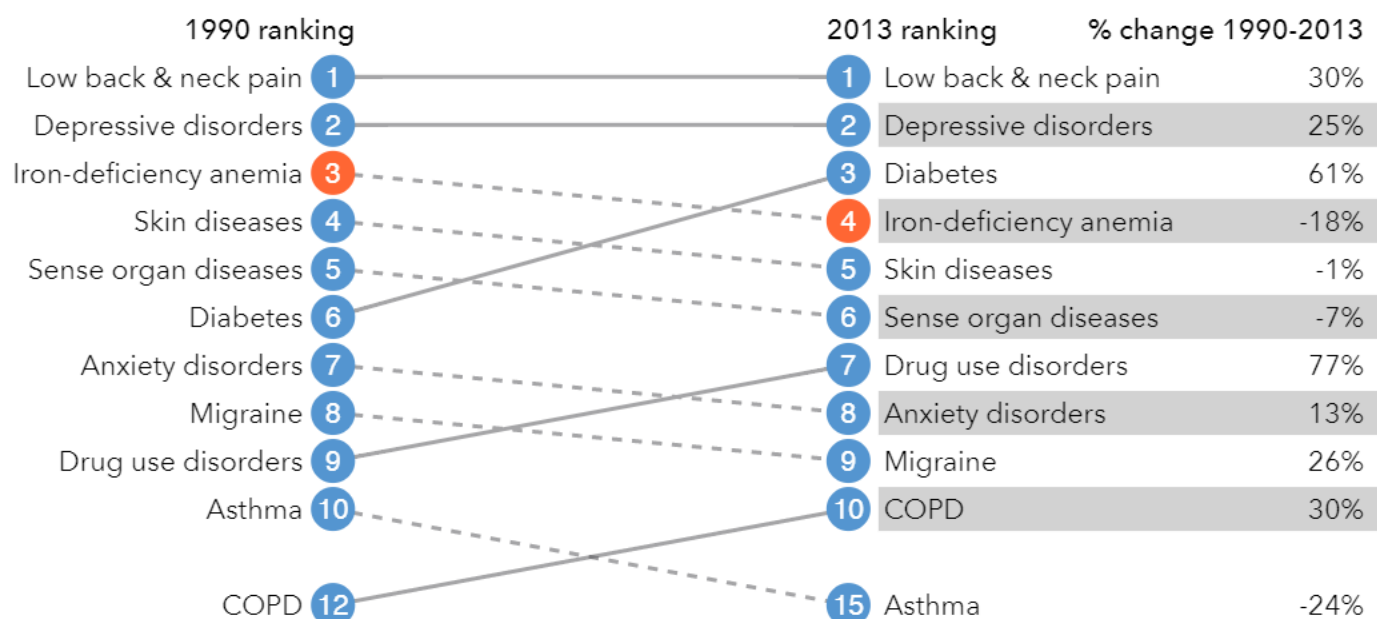

Rates of premature death in Jordan versus comparison locations, 2013

This table shows the top 10 causes of premature mortality in Jordan. It can be used to compare YLLs across locations relative to the group average. Comparison groups were chosen based on the GBD regional classifications, known trade partnerships, and income classifications.
