




# The burden of antimicrobial resistance (AMR) in Samoa

# AMR represents a global challenge

- **4.95 million** people who died in 2019 suffered from drug-resistant infections.
- AMR directly caused 1.27 million of those deaths.
- 1 in 5 of those deaths occurred among children under 5 years old.

Figure 1 Global number of deaths by GBD cause and those associated with AMR




The length of each bar states the number of deaths by GBD cause and those associated with AMR in 2019

## AMR burden in Samoa

- In Samoa in 2019, there were 29 deaths attributable to AMR and 109 deaths associated with AMR.
- Samoa has the 76th highest age-standardized mortality rate per 100,000 population associated with AMR across 204 countries.

Figure 2. Age-standardized mortality rate associated with AMR in 2019 for 204 locations




In the GBD region of Oceania, Samoa has the 7th lowest age-standardized mortality across 18 countries.





The number of AMR deaths in **Samoa** is higher than deaths from **chronic** respiratory diseases, respiratory infections and tuberculosis, digestive diseases, neurological disorders, and unintentional injuries.

Figure 3. Placing AMR in context with other causes of death in 2019, Samoa



- There are five pathogens to be aware of in Samoa (number of deaths associated with AMR in parentheses): Acinetobacter baumannii (15), Streptococcus pneumoniae (15), Escherichia coli (15), Staphylococcus aureus (15), and Klebsiella pneumoniae (14).
- These commonly caused bloodstream infections, lower respiratory infections and all related infections in the thorax, and peritoneal and intraabdominal infections.
- According to the Tracking AMR Country Self-Assessment Survey (TrACSS)1], "there is no National AMR action plan" in Samoa. The next step is that the plan should be "developed" in the short term, and this data should be used to ensure this progression.

## Addendum: A summary of data sources for Samoa

In total, 471 million individual records or isolates covering 7,585 study-location-years were used as input data to our estimation process to develop the most comprehensive set of AMR estimates to date. A subset of data pertinent to this country is shown below, and as our analyses depend on reliable data sources, there is a need to improve this in the future. Going forward, new strategies for data preparation, implementation of more usable data, and inclusion of new systematic literature reviews will result in an enhanced overall analysis. Specific policies that will improve AMR surveillance and link outcomes with resistance data will help us improve this research endeavor. If we expand the quantity and quality of data in this country (but also worldwide), we are confident that future iterations of these estimates (but also those of other research groups) will be able to assess the effect of AMR even more precisely and help tailor optimal approaches to ever-increasing threat of antibiotic resistance.
