






# The burden of antimicrobial resistance (AMR) in Sierra Leone

## AMR represents a global challenge

- **4.95 million** people who died in 2019 suffered from drug-resistant infections.
- AMR directly caused 1.27 million of those deaths.
- 1 in 5 of those deaths occurred among children under 5 years old.

Figure 1 Global number of deaths by GBD cause and those associated with AMR




The length of each bar states the number of deaths by GBD cause and those associated with AMR in 2019

### AMR burden in Sierra Leone

- In Sierra Leone in 2019, there were 2,200 deaths attributable to AMR and 9,700 deaths associated with AMR.
- Sierra Leone has the 15th highest age-standardized mortality rate per 100,000 population associated with AMR across 204 countries.

Figure 2. Age-standardized mortality rate associated with AMR in 2019 for 204 locations




In the GBD region of Western Sub-Saharan Africa, Sierra Leone has the 5th highest age-standardized mortality across 19 countries.





• The number of AMR deaths in **Sierra Leone** is higher than deaths from cardiovascular diseases, maternal and neonatal disorders, enteric infections, neoplasms, and other non-communicable diseases.

Figure 3. Placing AMR in context with other causes of death in 2019, Sierra Leone



- There are five pathogens to be aware of in **Sierra Leone** (number of deaths associated with AMR in parentheses): **Streptococcus pneumoniae** (2,000), **Klebsiella pneumoniae** (1,900), **Staphylococcus aureus** (1,300), **Escherichia coli** (1,300), and **Pseudomonas aeruginosa** (558).
- These commonly caused lower respiratory infections and all related infections in the thorax, meningitis and other bacterial central nervous system infections, bloodstream infections, and endocarditis and other cardiac infections.
- According to the Tracking AMR Country Self-Assessment Survey (TrACSS)1], "a
  National AMR action plan is being financed and monitored" in Sierra
  Leone. The next step is that the plan should be "provided with financial
  resources in national budget" in the short term, and this data should be used to
  ensure this progression.

### Addendum: A summary of data sources for Sierra Leone

In total, 471 million individual records or isolates covering 7,585 study-location-years were used as input data to our estimation process to develop the most comprehensive set of AMR estimates to date. A subset of data pertinent to this country is shown below, and as our analyses depend on reliable data sources, there is a need to improve this in the future. Going forward, new strategies for data preparation, implementation of more usable data, and inclusion of new systematic literature reviews will result in an enhanced overall analysis. Specific policies that will improve AMR surveillance and link outcomes with resistance data will help us improve this research endeavor. If we expand the quantity and quality of data in this country (but also worldwide), we are confident that future iterations of these estimates (but also those of other research groups) will be able to assess the effect of AMR even more precisely and help tailor optimal approaches to ever-increasing threat of antibiotic resistance.
